AN ACT TO AMEND THE ESTABLISHMENT OF TAASISI
YA KISWAHILI NA LUGHA ZA KIGENI (INSTITUTE OF
KISWAHILI AND FOREIGN LANGUAGES) DECREE, 1979
AND TO PROVIDE FOR BETTER PROVISIONS RELATING
TO THE SAME AND OTHER MATTERS CONNECTED THEREWITH.

Interpretation.

1. This Act may be cited as the Taasisi ya
Kiswahili na Lugha za Kigeni (Institute of Kiswahili
and Foreign Languages) (Amendment) Act, 1991 and shall
be read as one with the Taasisi ya Kiswahili na Lugha
za Kigeni Decree, No.4 of 1979 (hereinafter referred
to as the principal Decree).

2. In this Act, unless the context otherwise
requires :-

"President" means the President of Zanzibar and
Chairman of the Revolutionary Council.

Amendment of
section 4.

3. Section 4 is amended by -
- (a) deleting the words "based on old manuscripts and non-standard dialects of the Language" which appear in paragraph (b);
 - (b) deleting the words "neighbouring and other African Countries" which appear in paragraph (c) and replacing therefor the words "all other countries of the world";
 - (c) adding immediately after the words "to liaise and associate with the" and before the words "National Kiswahili Council of Tanzania (BAKITA)" which appear in paragraph (d) the following words :-

"National Kiswahili Council of Zanzibar (BAKIZA)".

Amendment of
section 6.

4. Section 6 of the principal Decree is hereby repealed and replaced thereof by the following new section :-

"Establishment
of
Council and
its
members.

- 6.(1) There shall be a Council of the Institute which shall consist of -
- (a) The Chairman who shall be appointed by the President;
 - (b) The Director of the Institute;
 - (c) the Director responsible for Research and Curriculum Development;
 - (d) the Director responsible for culture and Arts;
 - (e) the Director of Information and Broadcasting;
 - (f) the Director of Higher Education, Science and Technology;
 - (g) a member from Baraza la Kiswahili Zanzibar;
 - (h) a member from EACROTANAL;
 - (i) not more than six other members appointed by the Minister.

(2) All the members of the Council shall be published in the Official Gazette by the Minister.

(3) The members of the Council shall among themselves elect a Vice-Chairman, who shall hold office for so long as he remains a member of the Council.

(4) All appointed members under this section shall remain for a term of five years from the date of their appointment and may be eligible for re-appointment."

Amendment of section 9.

5. Subsection (1) of section 9 is hereby amended by deleting the word "four" and replaced thereof by the word "three".

Amendment of the principal Decree, No.4 of 1979.

6. The principal Decree is hereby amended by inserting new section 10A immediately after section 10.

" Appointment of Chief Academic Officer, Head of Department and their functions.

10.A The Council shall in consultation with the Director appoint -

- (a) Chief Academic Officer who shall be responsible for the following functions:-
- (i) to deal with all matters relating to academic issues;
 - (ii) to do any other functions delegated to him from time to time by the Council.
- (b) Heads of Department established by the Council from time to time."
