AN ACT TO REPEAL THE REVOLUTIONARY COMMITTEE'S
DECREE AND TO MAKE PROVISIONS FOR THE
ESTABLISHMENT OF THE MANAGEMENT COUNCIL TO
PROVIDE FOR ITS POWERS AND FUNCTIONS AND TO
PROVIDE FOR OTHER MATTERS CONNECTED THEREWITH
AND INCIDENTAL THERETO

ENACTED BY THE HOUSE OF REPRESENTATIVES,
ZANZIBAR.

Short title
and
commencement.

1. This Act may be cited as the Management
Council Act, 1986 and shall come into operation
immediately upon being assented by the President.
Government appointed.

Interpretation.

2. In this Act, unless the context
otherwise requires -

"Government" means the Revolutionary Government
of Zanzibar and includes its parastatals
and Special Department;

"Special Department" means special departments
as established by the Constitution;

"Independent Department" means department
other than that which has a direct
control from the Ministry.

Establishment
of the
Management
Councils.

3. There is hereby established -
(a) in every Ministry;
(b) in every Region and District;
(c) in every Independent Department;
(d) in every Public Enterprise; and
(e) in every Special Department,

a Management Council of that Ministry, Independent Department, Public Enterprise, Special Department or of the Region or District, as the case may be.

Composition
of the

4. The Management Council of each Ministry shall consist of -

- (a) the Minister responsible for that Ministry as Chairman;
(b) the Deputy Minister as deputy chairman;
(c) the Principal Secretary as Secretary;
(d) Chief Accountant;
(e) Heads of all departments which fall under that Ministry;
(f) Chairman of the Chama cha Mapinduzi branch of that Ministry;
(g) Chairman of JUWATA branch of that Ministry;
(h) all managers of parastatals which fall under that Ministry;
(i) Officer in charge of the Ministry in Pemba;
(j) Accountant of that Ministry in Pemba; and
(k) not more than five people who shall be elected by the Members of that Ministry.

Regional and
District
Management

5. The Management Council of each Region or District shall respectively be composed of -

- (a) the Regional or District Commissioner as Chairman;
(b) the Regional or District Administrative Officer as Secretary;
(c) Representatives of each Ministry in that Region or District as members;

- (d) Chief Accountant of the Region or District as members;
- (e) Chairman of JUWATA and Party Branch of the Regional and District Government as members:

Provided that the Regional Management Council shall in addition to the above members have the District Commissioners of that Region with their Administrative officers and chief accountants as members.

Composition

6. The Management Council of each Independent Department and each Public Enterprise shall consist of -

- (a) the head of that department or enterprise as a Chairman;
- (b) Chief Accountant as Secretary;
- (c) sectional heads within the Department or enterprise as members;
- (d) Chairman of the Party Branch of that department or enterprise;
- (e) Chairman of the JUWATA Branch of that department or enterprise;
- (f) not more than five members of that department or enterprise appointed by the department or enterprise;
- (g) for the department or enterprise having its offices in Pemba, the head and the accountant of that department or enterprise in Pemba.

7. In every Special Department the Management Council shall consist of -

- (a) the head of that Department as Chairman;
- (b) Chief Accountant of the Department as Secretary;
- (c) Political Commissor of that Department as member;

- (d) not more than five members of the Special Departments appointed from amongst the members themselves;
- (e) heads of the sections within that Special Department;
- (f) Officer in charge and political commissar of Special Department in Pemba;
- (g) Accountant of the Special Department in Pemba.

8. Every Ministry, Independent Department, Parastatal or Special Department which has its offices in Pemba shall establish the Management Council of that Ministry, Parastatal, Special Department or Independent Department in Pemba.

Composition.

9. The composition of the Management Council established under section 8 of this Act shall be composed of the following :-

- (a) Officer in charge of that Ministry, Independent Department, Parastatal or Special Department as Chairman;
- (b) Accountant of that Independent Department, Parastatal or Special Department as Secretary;
- (c) heads of the sections of that Ministry, Independent Department, Parastatal or Special Department as members;
- (d) Branch Chairman of C.C.M. as member;
- (e) Branch Chairman of JUWATA as member;
- (f) not more than five people who shall be elected by that Ministry, Independent Department, Parastatal or Special Department in Pemba;

Provided that the Political Commissar of each Special Department in Pemba shall also be a member.

Functions
of the
Management
Council.

10.(1) The Management Council shall be responsible for and ensure that -

- (a) discipline is maintained;
 - (b) work is done efficiently, orderly with punctual and regular attendance and workers' duties and obligations are properly carried out;
 - (c) the problems and the welfare or rights of the workers in that area are entertained in accordance with the prevailing laws and regulations;
- (2) The Management Council shall also be responsible for -
- (a) examining the budget and studying or adopting the development plans and the working programmes submitted by all departments and public enterprises including sections of the Departments under the Ministry;
 - (b) planning the ministerial development plans, the working programmes and the budget;
 - (c) directing and supervising Government programmes and ensuring their implementation at every stage;
 - (d) ensuring that there is a proper and rational utilisation of manpower, machinery and materials;
 - (e) generally advising on the proper implementation of the development plan policy and co-operation among the ministries; and
 - (f) to do other things which the Council shall think fit.

Meeting
of the
Council.

11.(1) A Council shall meet at least once in every four months but may at any time if needed call and convene a meeting at such place on such date and such time as it shall determine.

(2) All the meetings shall be chaired by the Chairman and in his absence by the deputy Chairman, or where there is no deputy Chairman by the Principal Secretary as acting Chairman or where there is no Principal Secretary any person who deputises the head of that Department or parastatal in case the head is not available.

(3) One half of all the members of the Council shall constitute a quorum at any meeting.

(4) The Secretary shall cause to be recorded and kept details of all business conducted at its meeting and the minutes of the meeting shall be read and confirmed at the next meeting of the Council and shall be signed by the Chairman.


12. All questions put before the Council for decision at any meeting shall be decided by a majority of the votes of the members present and voting and in the event of an equality of votes the Chairman or other member chairing shall have a casting vote in addition to his original vote.

13.(1) The Revolutionary Committees Decree number 1 of 1979 is hereby repealed.

(2) Any act done or rules made under the provisions of the Revolutionary Committees Decree shall be deemed to have been done under the corresponding provisions of this Act.

- (c) matatizo, maslahi na haki za wafanyakazi zinashughulikiwa;
- (2) Kamati ya Uongozi vile vile itawajibika -
- (a) kuangalia bajeti, mipango ya maendeleo pamoja na mipango ya kazi itakayowasili shwa na maidara, na mashirika yote ya umma, ikiwa ni pamoja seksheni za maidara yaliyo chini ya Wizara husika;
- (b) kupanga mipango ya maendeleo ya Wizara, mipango ya utekelezaji na bajeti;
- (c) kuongoza na kusimamia mipango ya Serikali na kuhakikisha utekelezaji wake katika kila hatua;
- (d) kuhakikisha matumizi ya hali ya juu ya wafanyakazi, mashine na bidhaa (materials);
- (e) kutoa ushauri wa jumla katika uetekelezaji wa sera za mipango ya maendeleo pamoja na mashirikiano baina ya Mawizara;
- (f) kufanya kitu chengine chochote ambacho Kamati itahisi inafaa.

(2) Mikutano yote itakuwa chini ya uenyekiti wa Mwenyekiti wa Kamati na iwapo Mwenyekiti hayupo basi naib wake au ikiwa hayupo basi Katibu Mkuu, na kwa pale ambapo hapana Katibu Mkuu mtu ye yote ambae humshikia madaraka mkuu huyo ikiwa ameondoka.

(3) Mikutano unaweza kufanyika iwapo wajumbe wasiopungua nusu wamehudhuria.
