AN ACT TO PRESCRIBE OATHS OF ALLEGIANCE,
OATHS FOR THE DUE EXECUTION OF OFFICES,
LETTERS OF APPOINTMENT AND OTHER MATTERS
CONNECTED THEREWITH AND INCIDENTAL THERETO.

ENACTED by the House of Representatives of
Zanzibar.

Short title and commencement. 1. This Act may be cited as the Oaths of Allegiance and Letters of Appointment Act, 1986 and shall come into force retrospectively from the first day of October, 1985.

Interpretation. 2. In this Act, unless the context otherwise requires :-

"appointment authority" means any person who is, under the provisions of the Constitution or any other law required to make certain appointments;

"Letters of appointment" means a letter of appointment prescribed under section 5 to this Act;

"oath of allegiance" means an Oath or Declaration made by any person so appointed to hold such office as may be described in the letter of appointment and includes such other oaths as may be necessary for the due execution of his office;

"Minister" means the Minister responsible for legal affairs;

"special Departments" means special departments as established by the Constitution.

By whom
Oath of

3.(1) Oath of allegiance shall be made by the following persons :-

- (a) the President;
- (b) the Chief Minister;
- (c) The Chief Justice and Judges of the High Court;
- (d) Ministers and other members of the Revolutionary Council;
- (e) the Deputy Ministers;
- (f) the Attorney-General;
- (g) the member of the House of Representatives;
- (h) the Speaker of the House of Representatives;
- (i) the Clerk to the House of Representatives;
- (j) the Controller and Auditor General;
- (k) the Permanent Secretaries of the Ministries;
- (l) the Regional and Area Commissioners;
- (m) any other person required to do so under the provisions of the Constitution or any other law for the time being in force.

(2) Without prejudice to the provisions of subsection (1) of this section the following persons shall also be required to take oath of allegiance :-

- (a) the Chief Kadhi;
- (b) Heads of the Special Departments;
- (c) Special Adviser to the President; and
- (d) Private Secretary of the President; and
- (e) Regional and District Administrative Officers.

(3) Every person mentioned under subsections (1) and (2) of this section shall not enter upon the duties of his office unless he has taken and subscribe the oath of allegiance and such oath for the due execution of his office as prescribed in Schedule One of this Act.

(4) All oaths made under this section shall be administered according to such forms as the Minister may from time to time prescribe.

Who may administer Oaths of allegiance.

4. An appointing authority for the post may, by himself or by an officer empowered by him on his behalf administer such oaths of allegiance:

Provided that the oaths of allegiance for the President, the Chief Minister, the Speaker and the Chief Justice shall respectively be administered by the Chief Justice, the President, the Clerk of the House of Representatives and the President.

Letters of appointment.

5.(1) Where any person has taken and subscribe the oath of allegiance, the appointing authority or as the case may be an officer empowered by him on his behalf to administer such oath of allegiance, shall hand over to the person so appointed and taken the said oath, letter of appointment indicating:-

- (a) the effective date of his appointment;
- (b) his duties; and
- (c) any other thing which the appointing authority shall think fit to indicate.

(2) The letters of appointment shall be in the form prescribed in Schedule Two to this Act.

Regulations.

6.(1) The Minister may make Regulations for the better carrying out of the provisions of this Act.

(2) The Minister may add to the list a name of any person who shall be required to take the oath of allegiance and the oath of due execution of his duties and such name or names shall be published in the Gazette.

Savings.

7. All oaths of allegiance taken before the commencement of this Act shall be taken as if done, taken and prescribed after the commencement of this Act.




