AN ACT TO AMEND THE JUMUIYA YA WAFANYAKAZI WA TANZANIA ACT NO.1 OF 1982 AND TO PROVIDE FOR MATTERS INCIDENTAL THERETO.

ENACTED by the House of Representatives of Zanzibar.

Short title

- 1.(1) This Act may be cited as the Jumuiya ya Commencement. Wafanyakazi wa Tanzania (Amendment) Act, 1992 and shall be read as one with the Jumuiya ya Wafanyakazi wa Tanzania Act, 1982, hereinafter referred to as the principal Act.
 - (2) This Act shall come into operation on such date as the Minister may by notice in the Gazette appoint.

Amendment of the principal Act.

The principal Act is amended by deleting the 2. words "Jumuiya ya Wafanyakazi wa Tanzania" also known by the acronym JUWATA wherever it appears in the principal Act and replaced by the words "Muungano wa Vyama vya Wafanyakazi Tanzania" entitled in English "Organisation of Tanzania Trade Unions" also known by the acronym OTTU.

Amendment of section

- 3. Section 2 of the principal Act is hereby amended by -
 - (a) deleting the words "the effective date" wherever they appear in the principal Act and its interpretation;



- (b) repealing the word "JUWATA" with its interpretation and replacing the following words:-
 - " "Constitution" means the Constitution of OTTU;

 "OTTU" means Organisation of Tanzania Trade

 Unions entitled in Kiswahili Muungano wa

 Vyama vya Wafanyakazi Tanzania established

 under its Constitution."
- (c) deleting the words "the Party" with its interpretation;
- (d) repealing the words "the rules" with its interpretation and replacing with the following:-" "the Rules" means the rules made under the Constitution."

Amendment of section 4.

- 4. Section 4 of the principal Act is amended by -
- (a) repealing the words "schedule to this Act entitled "Kanuni za Jumuiya ya Wafanyakazi wa Tanzania" which appear in the third and fourth lines of subsection (1) and replacing with the following word "Constitution".

Repeal and 5. Section 6 of the principal Act is hereby replacement of repealed and replaced by the following:-

"Cancellation of OTTU from the Register, Zanzibar.

6.(1) If the Registrar is satisfied that OTTU has failed to carry out its objects or that it is no longer in the public interest for it, as a trade Union, to carry on its activities any further in Zanzibar, he may by order published in the Official Gazette of Zanzibar, cancel registration of OTTU as a trade union.



- "(2) Where the Registrar is minded to make an order under subsection (1) he may either prior to making it or in the same or subsequent order establish, designate or make provision for the establishment or designation and registration of some other body representative of employees as a trade union, and shall the Registrar to cancel the registration of OTTU under the applicable legislation in Zanzibar.
- (3) Where the Registrar is minded to make an order under subsection (1), then -
 - (a) If no provision is made in the Constitution of OTTU for the disposition of its funds, the Registrar may include in the order such directions for the disposal of such funds as appear to him to be just and equitable, and, in any such case, the funds of OTTU shall be disposed of in accordance with those directions; and
 - (b) if the Registrar makes the order in accordance with subsection (2), the Registrar shall include in the order such directions for the disposal of the assets of OTTU to such new body and its assumption of the liabilities of OTTU as appear to him to be just and equitable and such directions shall have effect as if they had been set out in this section.
- (4) For the avoidance of doubt it is hereby declared that OTTU shall not have power to dissolve itself or to make provision for its own dissolution."
