**AN ACT TO AMEND THE ZANZIBAR INSTITUTE OF FINANCIAL
ADMINISTRATION ACT, 2005**

ENACTED by the House of Representatives of Zanzibar.

Short title and
commencement.

1. This Act may be cited as the Zanzibar Institute of Financial Administration (Amendment) Act, 2005 and shall come into operation immediately after being assented to by the President.

Construction.

2. This Act shall be read as one with the Zanzibar Institute of Financial Administration Act, No. 1 of 2002 herein after referred to as the principal Act.

Repeal of section 5.

3. Section 5 of the principal Act is hereby repealed.



Amendment of
section 7.

4. Section 7 of the principal Act is hereby amended as follows:

(a) by adding a new paragraph (b) as follows:

"(b) a vice chairperson who shall be appointed by the members among the members of the Council for a period of four years, and shall be eligible to be appointed for another term of office."

(b) by renumbering the existing paragraphs (b) to (k) to be paragraphs (c) to (i) accordingly.

Amendment of
section 11.

5. Section 11 of the principal Act is hereby amended as follows:

(a) by adding a new paragraph (a) as follows:

"(a) a chairperson who shall be appointed by the members among the members of the Council and shall be eligible to be appointed for another term of office."

(b) by renumbering the existing paragraphs (a) to (g), to be paragraphs (b) to (h) accordingly;

(c) by deleting the word chairperson in paragraph (b) and replace it by the words "member of the committee."



Amendment of section 12.

6. Section 12 of the principal Act is hereby amended by adding a new paragraph (f) immediately after paragraph (e) as follows:

"(f) to do any other duties assigned to it by the Council".

Amendment of section 13.

7. Section 13 of the principal Act is hereby amended by deleting paragraphs (a) to (f) and replacing by the following:

- (a) a member of the Council who shall be the chairperson;
- (b) the Principal who shall be the member of the committee;
- (c) the Chief Administrative Officer who shall be the Secretary of the Committee;
- (d) the Chief Academic Officer;
- (e) Heads of Departments;
- (f) the Accountant General's;
- (g) the Director of Department of Civil Service Zanzibar.

Addition of new sections 19A and 19B.

8. The principal Act is hereby amended by adding new sections 19A and 19B immediately after section 19 as follows:



"Registrar. 19A.(1) There shall be a Registrar who shall be appointed by the Council.

(2) A person shall be qualified to be Registrar if he has:

(a) professional qualification and experience in Management Economics, Finance, Accounting and related fields of specialization at master level;

(b) an experience in academic matters for a period of not less than 5 years.

(3) The Registrar shall hold office for a period of 4 years and may be reappointed for a final term of 4 years.

(4) The Registrar shall be answerable to the Chief Academic Officer.

Functions of the Registrar.

19B. The Registrar shall be duty bound to perform the following functions:

(a) to be responsible for all matters related to students registration and examination;



(b) *any other duties that shall be determined by the Council.*"

Amendment of section 20.

9. Section 20 of the principal Act is hereby amended in subsection (1) by deleting paragraphs (a) to (f) and substituting for the following:

- (a) Department of Economics and Mathematics;
- (b) Department of Finance and Accounting;
- (c) Department of General Studies and short courses;
- (d) Department of Information Technology;
- (e) Department of Library Services.

Amendment of section 26.

10. Section 26 of the principal Act is hereby amended in subsection (1) by deleting that subsection and substituting for the following:

"(1) The Management Committee shall be disciplinary organ, which shall administer all disciplinary action of the Institute and shall be headed by the Principal.

Amendment of section 28.

11. Section 28 of the principal Act is hereby amended by deleting the word "principal" appeared in subsection (1) and substituting for the words "Management Committee".



Amendment of
section 30.

12. Section 30 of the principal Act is hereby
amended as follows:

(a) by adding a new subsection (1) as follows:

*"(1) There shall be an Appellate
Committee which shall hear and determine all the
appeals made against the decisions of the
Disciplinary Organ.*

(b) by renumbering the existing subsection (1)
as subsection (2) and shall read as follows:

(i) a member of the Council shall be the
Chairman;

(ii) the Principal;

(iii) a member from Academic Planning
Committee;

(iv) a member from a Financial and Human
Resources Committee;

(v) a representatives from the Attorney
General's Chambers appointed by the
Attorney General;

(vi) a member from students organization.

(c) by renumbering the existing subsection (2) to
be subsection (3).



Amendment of
section 40.

13. Section 40 of the principal Act is hereby amended in subsection (2) by deleting paragraph (b) and substituting for the following:

“(b) A cash flow statement”.
