AN ACT TO AMEND THE STATE UNIVERSITY OF
ZANZIBAR ACT, NO. 8 OF 1999

ENACTED by the House of Representatives of Zanzibar.

PART ONE
PRELIMINARY PROVISIONS

- Short title and commencement. **1.** This Act shall be cited as the State University of Zanzibar (Amendment) Act, of 2009 and shall come into operation immediately after being assented to by the President.
- Construction. **2.** This Act shall be read as one with the State University of Zanzibar Act, No. 8 of 1999 in this Act referred to as the "Principal Act".

PART TWO
AMENDMENT PROVISIONS

- Amendment of section 2. **3.** Section 2 of the Principal Act is hereby amended as follows:
- (a) by adding letter "s" after the words "Deputy Vice Chancellor".
 - (b) by deleting the word "Registrar" in the interpretation section and wherever appeared in the Principal Act.



Amendment of section 10. **4.** Section 10 of the Principal Act is hereby repealed and replaced by the new section as follows:-

“Deputy Vice Chancellors Academics and Administration.

10.(1) There shall be Deputy Vice Chancellors for academics and administration of the University who shall be appointed by the President upon consultation of the Council.

(2) The President may appoint other Deputy Vice Chancellors upon consultation of the Council by submitting not less than three names.

(3) A person shall not be appointed as Deputy Vice Chancellor unless he has seven years working experiences in academics, administration and knowledge to work as Deputy Vice Chancellor.

(4) The Deputy Vice-Chancellors shall hold office for a term of three years and may be reappointed for another one term of three years.

(5) The Deputy Vice-Chancellors shall be the principal assistants and responsible to the Vice-Chancellor in all matters pertaining to the activities and life of University.

(6) The Deputy Vice-Chancellors shall have such other functions as are conferred upon them by this Act or as may be prescribe by the Council.”

Amendment of section 11. **5.** Section 11 of the Principal Act is hereby repealed.

Amendment of section 12. **6.** Section 12(1)(c) of Principal Act is hereby amended by deleting the letters “an” between the words “be” and ex-officio, and adding letter “s” at the end of the word “member”.

Amendment of section 14. **7.** Section 14.(1) of the Principal Act is hereby repealed and replaced by the following new section:

14.(1) The Deputy Vice Chancellor Academic shall be the Secretary to the Council.



Amendment of section 16. **8.** Section 16(1) of the Principal Act is hereby amended by repealing paragraphs (b) and (c) and replaced by the new paragraphs (b) and (c) as follows:-

(b) the Deputy Vice-Chancellor Administration who shall be Vice Chairperson;

(c) the Deputy Vice-Chancellor Academic.

Amendment of section 17. **9.**Section 17 of the Principal Act is hereby amended by deleting sub section (7).

Amendment of section 18. **10.** Section 18(1) of the Principal Act is hereby amended by repealing paragraphs (b) and (c) and replaced by the new paragraphs (b) and (c) as follows:

(b) the Deputy Vice-Chancellor Administration who shall be Vice Chairperson;

(c) the Deputy Vice Chancellor Academic.

Amendment of section 23. **11.** Section 23 of the Principal Act is hereby amended by deleting the words "Deputy Vice Chancellor" appeared in paragraph (a) and replaced by the words "Deputy Vice Chancellor Academic".

Amendment of section 26. **12.** Section 26 of the Principal Act is hereby amended by inserting the words "Deputy Vice Chancellor Administration" in paragraph (a).

Amendment of section 37. **13.** Section 37 of the Principal Act is hereby amended by repealing sub section (2) and replaced by the new sub section (2) as follows:

"(2) The Deputy Vice Chancellor Academic shall cause to be compiled and maintained a Convocation roll in which shall be entered the name of all persons who are for the time being members of the Convocation."

Amendment of section 40. **14.** Section 40 of the Principal Act is hereby amended by repealing sub section (1) and replaced by new sub section (1) as follows:

40.(1) The Deputy Vice Chancellor Academic shall be the Secretary of the Convocation."



Amendment of section 15. Section 41 of the Principal Act is hereby repealed and replaced with the new section as follows:-

41. Deputy Vice Chancellor to report on business of Convocation. **41.**(1) The Deputy Vice Chancellor Academic shall report to the Council the activities of the Convocation and shall transmit to the Chancellor, the Council or the Senate as the case may be any resolution passed by the Convocation.
- (2) The Deputy Vice Chancellor Academic shall send a copy of the minutes of every meeting of the Convocation to the Chancellor.

Amendment of First Schedule. **16.** Section 11(2) of the First Schedule is hereby amended by renumbering paragraph (d) to be read (c).

Amendment of First Schedule. **17.** Section 12 of the First Schedule is hereby amended by renumbering paragraph (d) to be read (c).

Amendment of Second Schedule. **18.** The opening words in section 1(1) of the Second Schedule is hereby repealed and replaced by the following new words:

1.(1) Where a vacancy occurs in the post of the Bursar or any Senior Administrative Officer, the Deputy Vice Chancellor Administration shall cause the vacancy to be advertised in such manner as the Deputy Vice Chancellor Administration may consider fit and shall submit to the Appointment Committee the names of all persons who have applied for the post and shall, after consultation with the Deputy Vice-Chancellors make recommendations to the Appointments Committee as to:-

Amendment of Second Schedule. **19.** Section 2 of the Second Schedule is hereby amended by:

- (a) deleting the words "and the" appeared after the words "Vice-Chancellor" in subsection (1) and (2);
- (b) deleting the word "Registrar" and replaced by the words "Deputy Vice Chancellor Administration in subsection (3)".
