**AN ACT TO APPROPRIATE THE SUM OF SIX TRILLION,  
NINE HUNDRED EIGHTY TWO BILLION, SEVENTY SIX  
MILLION, NINETY EIGHT THOUSAND, AND THIRTY  
SEVEN SHILLINGS OUT OF THE CONSOLIDATED  
FUND FOR THE YEAR ENDING ON THE THIRTIETH  
DAY OF JUNE, TWO THOUSAND AND TWENTY SIX,  
TO AUTHORISE THE REALLOCATION OF CERTAIN  
APPROPRIATION AND TO PROVIDE FOR OTHER  
MATTERS CONNECTED THEREWITH**

Short title.

**1.** This Act may be cited as the Appropriation Act, 2025.

**2.** The expression used in this Act, shall have the meaning ascribed to it in the Public Finance Management Act, No. 12 of 2016.

**3.** The Government Treasury may issue out of the Consolidated Fund of the Government the sum Six Trillion, Nine Hundred Eighty Two Billion, Seventy Six Million, Ninety Eight Thousand, and Thirty Seven Shillings for the Expenditure of the service of the year ending on the 30th day of June, 2026, where by the sum of Six Trillion, Six Hundred Twenty Two Billion, Six Hundred Seventy Nine Million, Nine Hundred Sixty Five Thousand Shillings for Expenditure of Central Government and a sum of Twenty One Billion, Six Hundred Sixty Nine Million, Two Hundred Sixty Four Thousand, and Eighty Seven Shillings for Expenditure of Local Government Authority, and for the Expenditure of Government Independent Institutions is Three Hundred Thirty Seven Billion, Seven Hundred Twenty Six Million, Eight Hundred Sixty Eight Thousand, and Nine Hundred Fifty Shillings.

Power of

**4.-(1)** The Minister responsible for finance may, at any time not later than the 30 day of June, 2026, borrow within or outside Zanzibar any sum not exceeding the total sum granted or deemed to have been

granted out of the Consolidated Fund under the provisions of section 3 of this Act by way of loan, advance, the issue of bills, bonds or bank overdraft and on such terms and conditions as the Minister may deem expedient, and may charge that loan or advance on any of the assets of Zanzibar including securities forming part of the Consolidated Fund of the Government.

(2) The money borrowed under subsection (1) of this section, shall be credited to the exchequer account and shall form part of the Consolidated Fund of the Government.

(3) The money borrowed under subsection (1) of this section, shall be repaid in accordance with the agreed terms and conditions and the funds required to repay the loan interest shall be disbursed and repaid from the Consolidated Fund of the Government.

(4) The powers conferred upon the Minister under subsection (1) of this section, shall be in addition to the power of the Minister conferred upon him under the provisions of this Public Finance Management Act, No. 12 of 2016.

**5.-**(1) Where the Minister responsible for finance is satisfied that, it is necessary for the public interest, to provide the supplementary expenditure for any Ministry or Department of the Government in excess of any sum voted for it or for any service for which the sum is not voted, and that it would be detrimental to the public interest to postpone the expenditure until provision can be made for it by the House of Representatives, he may, notwithstanding any provision under this Act or any other law, authorize the surplus on any vote prescribed in the Schedules of this Act.

(2) Where the Minister authorizes the surplus under this section, he shall, as soon as practicable after authorization, cause to be laid before the House of Representatives a supplementary estimate of a statement of re-allocation as the case may be in accordance with the provisions of section 106 (2) of the Constitution of Zanzibar, 1984 if such re-allocation results in a surplus expenditure.

(3) The Minister may delegate his powers conferred under this section to any public officer in accordance with terms and conditions as he may specify.

**6.** The sum required any time for public loans redemption and repayments of interests in respect of financial year 2025/2026 is Two Hundred Forty Five Billion, Four Hundred Fifty Million, Five Hundred Twenty One Thousand Shillings shall be paid out of the Consolidated Fund of the Government.

**7.-(1)** The sum granted under section 3 of this Act, is hereby approved for recurrent and development expenditure and shall be applied for the purposes and amounts specified in the Schedule of this Act.

(2) The estimate budget for recurrent and development expenditure by program for the financial year 2025/2026 shall be prescribed in the Schedule of this Act.

**8.** The sum of Five Hundred Thirty Eight Million, Eight Hundred Thousand Shillings granted under section 3 of this Act, is hereby approved from Basket Fund from Development Partners.
